

The candidates should bring **all original certificates** of educational qualifications (from SSC onwards), experience, Aadhaar Card, OBC/ SC/ ST Community and PH Certificates along with one set of photocopies of the same duly attested (can be self attested) along with a passport size photograph for attending the Written Test/ Interview. The persons belonging to Other Backward Category should bring the latest O.B.C. (Non-creamy layer) Certificate issued by the respective Tahsildar/ MRO specifically issued for the purpose of applying for Central Government Posts. **No TA/ DA will be paid for attending the Written Test/ Interview.** The recruited project staff is eligible for leave as per rules and will have to give an undertaking before joining.
