- పదకొండవ సంవత్సరం : పదకొండవ సంవత్సరం నేటికే ఆంధ్రప్రదేశ్ ప్రభుత్వం పదకొండవ సంవత్సరం పట్ల
- **Rule : Communication received in Hindi must be replied in Hindi only.**
  - పదకొండవ సంవత్సరం (1976) : పదకొండవ సంవత్సరం ప్రభుత్వం పదకొండవ సంవత్సరం పట్ల
  - **Rule (i) : An employee may submit an application, appeal or representation in Hindi or in English.**
  - (1976) : పదకొండవ సంవత్సరం ప్రభుత్వం పదకొండవ సంవత్సరం పట్ల
  - **(ii) : Any application, appeal or representation if made or signed in Hindi, shall be replied to in Hindi.**
