## **INFORMATION AND GUIDELINES FOR BIDDERS**

- 1. Fill in the specification sheets supplied with Tender Form for each item giving availability of facility for production of vaccine.
- 2. Separate quotations must be submitted for each item specified in the tender notice. Taxes, duties, packing & forwarding charges, transport & insurance charges may be separately indicated where applicable.
- 3. Reputed manufacturers of the product (specified in the tender notice) or their authorized agents with well-established sales and services facilities only need to respond to the tender notice.
- 4. In case the bidder is an authorized agent, documentary proof to this effect may be enclosed with the quotation.
- 5. Bidders detailed company profile, information on post-supply of vaccine support/ assistancy may be given along with the quotation.
- The tender should contain full technical specifications of expertise with supported necessary documents.
- 7. An earnest money deposit of 3% of the estimated value of the quote (tender) should be submitted along with the quotation (in Price bid) through a demand draft drawn in favour of the Director, National Institute of Nutrition, Hyderabad.
- 8. Earnest money will be liable to be forfeited if the tenderer withdraws, amends, impairs or derogates from the tender in any respect within the period of validity of his tender.
- 9. The Earnest money of the successful tenderer shall be refunded after the security deposit as required vide rule 158 of the General Financial Rule. The earnest money can be adjusted against the security deposit required to be furnished by the successful bidder.
- 10. If the successful bidder fails to furnish the security deposit as required vide rule 157 of the General Financial Rules, then the earnest money shall be forfeited by the date of opening tender.
- 11. The bidder must furnish a list of customers to whom such vaccine production was undertaken in India. Name and contact telephone no. of the customer may be furnished.
- 12. Quotations must be furnished in a sealed envelope separately for the item quoted under the tender. The name of the item quoted and tender notice particulars should be clearly indicated on the top of the envelope.
- 13. Bidders are requested to carefully go through the specifications given in the tender and quote only when they are sure that they have the product specified to offer. In case of any doubts the bidders can contact **Dr. B. Dinesh Kumar, Scientist 'F'and HOD, Drug Toxicology Division at NIN** on any working day with prior appointment.

14.	Technical bid and price bid should be submitted separately under wax sealed covers, and both the envelopes put together in another cover which should also be wax sealed. This is to
	ensure that if the technical bid qualifies with the laid down specifications and configurations
	only then price bid will be opened. Otherwise, the price bid will automatically get rejected
	along with the technical bid not fulfilling the specifications/configurations. The envelopes
	should super-scribed as "Technical bid for (name of the vaccine)"
	"Quotation for Price Bid for (name of the vaccine)" both envelopes
	together in third envelope super-scribing "Quotation for name of the vaccine & tender
	document Name & No " respectively.

## TENDER DOCUMENT FEE SHOULD BE SUBMITTED IN A SEPARATE COVER ALONG WITH THE TECHNICAL BID.

- 15. The technical bid must have the following enclosures:
  - a) True copy of the commercial bid and a copy of EMD but with the prices omitted. All items quoted must be clearly indicated. Prices must not be indicated.
  - b) Detailed illustrative pamphlets, company profile, customers list & questionnaire duly filled.
- 16. The original D. D. of the EMD should be kept in a separate cover along with the commercial bid.
- 17. Latest income tax and sales tax clearance certificate must accompany the technical Bid.
- 18. Authorized dealers should submit a copy of valid dealership certificate along with quotation.
- 19. The tender rates shall be valid for **120 days** from the date opening tender.
- 20. Last date for the receipt of the sealed quotations up to **5.00 p.m. on 18.9.2017**
- 21. Late/delayed offers will not be accepted.
- 22. Conditional and telegraphic tenders shall not be accepted.
- 23. In the event of any date indicated above is a declared holiday the next working day shall become operative for the respective purpose mentioned therein.
- 24. The technical bids will be opened on 21.9.2017 at 10-30 A.M. onwards in the presence of the Bidders or their authorized representative in the office of the Director, National Institute of Nutrition. It is the responsibility of the bidders to present themselves at the time of opening of the technical bids. The date of Price bid opening will be intimated to the QUALIFIED BIDDERS ONLY at a later date.

- 25. Bidders have to enclose the Questionnaire duly filled and signed along with the Technical Bid. Offers without the filled in Questionnaire/unsigned questionnaire will be summarily rejected.
- 26. The Director of the Institute reserves the right to accept or reject any offers in part or whole without assigning any reason/s whatsoever.
